CLINIC: Saturday, December 3rd from 12pm to 1:30pm at the La Sierra Community Center

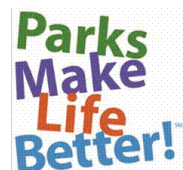
PRACTICES: Times and days vary and will be determined at the clinic.
