Subject: Award Contract #24-0001 for the Kids Hang Out Flooring Project

Background/Discussion:

As part of the FY 2023-24 Capital Project List (CIP) Budget, the Advisory Board approved an allocation of \$120,000 for the Kids Hang Out Flooring Project. This report presents an evaluation and recommendation for awarding the contract for that project.

On January 17, 2024, a Notice – Request for Bid Proposals was advertised. Bid openings were held on February 8, 2024. The project received one bid from a reputable firm: Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies. The bid has been carefully reviewed for compliance with the necessary requirements, including costs for performance/payment bonds.

The following firm submitted a proposal:

 Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies, Inc. with a bid in the amount of \$106,380.60.

Based on the evaluation of the bid, it is recommended that Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies be awarded Contract #24-0001 for the Kids Hang Out Flooring Project. The key factors influencing this recommendation are as follows:

1. Lowest Bid: Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies submitted the lowest bid amount of \$106,380.60. Selecting the lowest bid helps ensure efficient use of funds while maintaining the quality of work.

- 2. Responsible Bid: Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies has demonstrated their responsibility by fulfilling all the necessary bid requirements, including incorporating the costs for performance/payment bonds. This indicates their understanding of project management and their commitment to delivering a satisfactory outcome.
- 3. Reputation and Experience: Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies is a reputable firm with a track record of successful projects all over the Sacramento region, including 3 for us in the last 7 years. Their experience and expertise make them a reliable choice for executing the flooring project at the La Sierra Community Center Kids Hang Out.

RECOMMENDATION:

Staff recommends approval by the Advisory Board to award the bid from Gustave Enterprise Inc., dba Creative Floor Covering Sales and Supplies as the lowest responsible bidder and enter into Contract #24-0001 in the amount of \$106,380.60 for the Kids Hang Out Flooring Project; delegate authority to the District Administrator or designee to execute the Contract.
