Junior Leaders may not arrive before or stay later than their scheduled shift unless otherwise approved by the Recreation Coordinator. Staff meetings will be every other week between 12:30 pm-1:00 pm. Your position as a Junior Leader is dependent upon your work performance. Recreation staff will be contacting my child directly, outside of initial registration and contact at the beginning of the program, unless there is an emergency or other situation/information that program staff determine is best communicated to adults. This is to help teach independence and responsibility for the Junior Leaders in the program.
